45, 47 & 49 Hangars

Jerry Ann Conner and Michael Fouts discussed the execution of P & S for 45,47 & 49 hangars at the Airport Authority. Coweta County had purchased the hangars and improvements and had transferred them to the Coweta County Development Authority at the acquisition. The P & S required \$400,000 nonrefundable earnest money to paid to Coweta County and apply to the purchase price of \$4,000,000.00 which would close in 18 months. All proceeds of the sale would go to the County. Michael Fouts explained that this would allow for the termination of a 99-year lease with the prior owner which was in violation of FAA. In addition, the new owner would be relocating its office and bringing employees, taxable equipment and airplanes, and would also provide significant rental revenue for the airport authority. Upon finding that this transaction furthered economic development and provided employment opportunities, the following motions were made:

NEW BUSINESS

Hail Aircraft

Discussion was had regarding economic incentives for Hail Aircraft looking to locate at the Newnan-Coweta Airport. Michael Fouts and Trae Westmoreland reported that Hail was entering into a 25-year lease with the Airport Authority, would be bringing 20 jobs and investing 5 million in capital. The project was not large enough for the issuance of a bond but that the addition of the company would be a significant benefit to the airport and the county. It was suggested that the Authority use \$22,477.50 of its bond fees to assist the company with the payment of rental since the Airport Authority was prohibited by law from waiving rental fees. The Airport Authority had agreed to allow the company to suspend rental payments for the first 6 months and pay on the back side of the 25-year term. Discussion was had as to the proper use of the bond fees and whether it should be used for this purpose. A MOTION was **MADE**, and **CARRIED** to **APPROVE** the provision of a grant of \$22,477.50 to Hail Aircraft with

claw back provisions and job and investment obligations determined and agreed upon by the President.
