Discussion on Financials

Treasurer voiced concerns over approved checks. Common bills get sent to County for paying invoices. Out of normal requests/expense get permission from JD or Norm. Project Manager found two fraud charges on bond account. Peer to peer deposit in February. Police report filed and Truist is working to re-fund the account. County also brought to attention another fraud check. This check was from operating account. Treasurer would like to create an SOP for financial expenditure/check submittal.

The Chason Group - Phase I Report

The Chason Group presented on the Phase 1 report. There was reported answers to the stakeholder interviews and ultimately no common vision among the board. The Board needs clarity on objectives and goals for the incoming president. The Board feels there is no strategic plan and no funding in place to carry out the strategic plan. Budget and facilities available will limit potential candidates. There is some similarity among the Board on industries desired and not desired. Skill sets listed for the new proposed job description were all inside the norms. Looking for someone to lead us. Point person for economic development. At least 5 yrs., strong communicator, understand how to build relationships and collaboration. Internal and external. Lead a team. Recommending annual base salary up to \$150k plus 10% incentive plan in the 2nd year. 1-2 yrs. person

is asking for \$110k. more experienced is \$125k - \$150k. Recommended to ask if they can be covered (insurance) on 1st day of employment and receive annual leave.
